INTRODUCTION

The Canadian Forest Fire Danger Rating System (CFFDRS) is the national system of rating fire danger used in Canada. The CFFDRS has been under development, by the Canadian Forestry Service (CFS), in its present form since 1968. This report is a bibliography containing 331 items (Table 1), including both published (nos. 1-198) and limited distribution (nos. 199-280) references, pertaining to the CFFDRS produced by CFS fire research staff and others during the period from 1969 to 1985; 1986 (nos. 281-300) and 1987 (nos. 301-331) supplements have also been included [the latter supplement includes two previously overlooked items]. Items are listed in alphabetical order by the author's last name; those written by the same person(s) are listed in chronological order. Although considerable care was taken to ensure completeness, there probably are omissions. Users of this bibliography are encouraged to bring these to the author's attention. Please note, however, that the final selection of references included in the "limited distribution" category remains a personal judgment on the part of the author. Certain types of material have been purposedly omitted (e.g., agency training manuals, file reports, university course texts). To ensure that the bibliography is more than just a list, area and subject indexes, keyed numerically to the references, have been included (p. 30-33). A number under the index identifies the item which is contained in the alphabetical listing. A reference may appear more than once within the area index but would only be noted one time under the subject index.
